

Raven Protocol

Our best practice notification protocol includes notifying the attending service of record for all of the following resident conditions:

- unexpected death
- significant deviation from baseline/significant change in functional status
- any acute illness/high risk for terminal decline
- any change to POLST or goals of care discussion
- any transfer to the hospital
- aggressive treatment such as IV fluids or IV antibiotics
- any outstanding diagnostics that may result to you overnight
